



Clinical Policy: Nonpharmacological Treatments for Depression

Description

This policy describes the medical necessity guidelines for nonpharmacological treatments for treatment-resistant depression (TRD), specifically electroconvulsive therapy, deep brain stimulation and transcranial direct current stimulation.

Transcranial magnetic stimulation (TMS) is addressed in policy WA.CP.BH.200.

Policy/Criteria

- I. It is the policy of Coordinated Care of Washington, Inc., in accordance with the Health Care Authority's Health Technology Assessment, that electroconvulsive therapy is **medically necessary** for treatment resistant depression as defined in InterQual criteria.
- II. It is the policy of Coordinated Care of Washington, Inc., in accordance with the Health Care Authority's Health Technology Assessment, that deep brain stimulation and transcranial direct current stimulation is **not medically necessary** for treatment resistant depression.

Background

This policy is based entirely on Washington State Health Care Authority (HCA) Health Technology Assessment (HTA).
